

# SKIING AND THE LAW by Roman Karwowski

A skier and his friend were skiing at night through a cluster of trees that Mt. Brighton Inc. considered as an out of bounds area. Mt. Brighton did not fence or rope off the area or mark it closed. In attempting to ski down a trail through the cluster of trees, the skier struck what he has described as a uniquely shaped tree. As a result the skier was seriously injured. The skier sued the ski area alleging that the area was negligent with respect to the lighting and grooming of the treed area and in failing to post warnings or mark the ski area as closed.

The Michigan Court of Appeals held that the risks assumed by a skier under the Ski Area Safety Act are natural obstacles such as trees and rocks and denied relief to the skier. Barr vs. Mt. Brighton Inc. 215 Mich App 512 (1996)

# WHAT'S THIS "RACING CLASS" THING? by Alan Toomey

As I have been President of the GM Ski Club I have become more interested in the information concerning a group of our members who are representing our Club in the MACC (Michigan Alpine Competition Committee) program. I have learned more about it as the season has gone on. I know our race Chairpersons Karen Brown and Roman Karwowski have been promoting the race program for any level skier. I have found a tremendous amount of information on the MACC Website (MACCRACING.org) that helped me understand how racers are classified and why your average skier could participate within his or her own skill level grouping.

The attached table, an excerpt from the web site, should help you understand the reporting of the race results. I hope those of you who were somewhat interested but let this year pass, take the opportunity to join in for next seasons events.

### 7. RACER CLASSIFICATION

### 7.1. Class Definitions

- 7.1.1 Racers are classified by sex, ability, and (optionally) age. There are five basic ability groups: Elite, A, B, C, and D, where each is defined by a range of handicaps. However, large groups may be split into groups 1 and 2 (e.g., Elite 1, Elite 2). Large groups may also be split by age (e.g., vet, super-vet).
- 7.1.2 The table below shows the 1999 classes and handicap ranges for male racers.
