




Sunday Afternoon Wallyball





Wednesday, February 28th was a glorious day to begin a vacation. Ski club members headed south to Canada through the tunnel (stopping at duty free of course) and on to the Windsor Airport. Our flights to Toronto and then on to Montreal were on schedule, as was the shuttle that took us from the airport to the front door of The Fairmont Tremblant, formally the Chateau Mont Tremblant.

After a little sightseeing, shopping and dinner, we made it an early evening so we could prepare for skiing Thursday morning.

Quebec is known for its cool weather, and this vacation was no exception. Days were in the teens getting a little warmer each day and in the single digits each night plus and minus 0 F. We also had snow, lots of it.

Skiing was excellent. Virtually every run goes from the top of the 2150' mountain to the bottom, both north and south sides. There were



colors, but best of all there were cruisers in black, blue and green. Craig Hufnagel and I set personal one, two and three day vertical records. Other than a couple of inches of snow Friday afternoon, the skies were clear and the sun was bright the whole time. Each day of skiing was followed by a

relaxing hour in the hot tub. The hotel had an inside and an outside pool, plus one indoor and two outdoor hot tubs. The sauna, exercise room and showers were also a nice touch.

A big air run was set up at the base of the hill at the resort. Boarders and skiers entertained us day and night Thursday, Friday and Saturday.



Election of Officers—Vote April 12

President

The President shall be the Chief Executive Officer of the Club. He shall preside at all meetings; he shall be responsible for all orders and resolutions being put into effect, he shall appoint necessary committee chairmen.

If all officers are absent, the general meeting shall be presided over by a person designated by the President.

Vice-president

The Vice President shall assist the President in the discharge of his duties; he shall, in the absence of the President, perform the duties of that office; he shall serve as parliamentarian and chair of any special

Constitutional Committee.

Secretary

It shall be the duties of the Secretary to send proper notices of all meetings to the Board of Directors and the general membership; to keep the minutes of each meeting and to furnish copies of these minutes to the Board of Directors and to conduct the correspondence pertaining to that office.

Treasurer

The Treasurer shall be responsible for the funds of the Club; he shall keep correct an itemized account of all receipts and disbursements; he shall deposit all monies in the name of, and to the credit of, the Club; he shall take proper vouchers for all disbursements and shall render, upon request, to the membership at any meeting, an account

of all transactions performed by that office and of the financial condition of the Club; he shall present a financial statement at the end of his term of office. The treasurer shall publish a monthly statement in the Club newsletter on the financial condition of the Club.
